If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation if prudent and bring such to the attention of the nearest official immediately; and

I, for myself and on behalf of my heirs, assigns, and personal representatives and next of kin, hereby release, indemnify, and hold harmless Victory Valley Camp, their officials, officers, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers and if applicable, owners and lessors of premises used to conduct the event, with respect to any and all injury, disability, death, or loss or damage to person or property, whether arising from the negligence of the releaser or otherwise, to the fullest extent permitted by law.
